

## **UNMANNED AERIAL VEHICLES (UAV) POLICY**

Popularly known as drones, but also referred to as remotely piloted aircraft systems (RPAS) or unmanned aerial vehicles (UAV) they come in a variety of shapes and sizes, ranging from small handheld types up to large aircraft, potentially a similar size to airliners.

Just like any other aircraft, an unmanned aircraft must always be flown in a safe manner, both with respect to other aircraft in the air and also to people and properties on the ground.

Permission must be gained from the circuit in advance of the event should you wish to fly a drone over our venue.

## Remember

- You are responsible for each flight
  - Please ensure you know the rules for flying drones in the United Kingdom as you are responsible for every flight. Failure to comply with CAA rules may result in prosecution.
- You are responsible for avoiding collisions
  - You should never fly a drone near and aircraft and it is a criminal offence to endanger the safety of an aircraft in flight.
- Keep your drone in sight
  - You must keep your drone in sight at all times and stay below 400 feet
- Keep your distance
  - It is illegal to fly a drone over a congested area, such as the Paddock or Spectator Enclosures. Please also ensure you do not fly too close to any buildings or vehicles on the site.
  - Please do not fly too low to the circuit as this may distract the circuit users and cause an accident. If you fly too low you may be asked to go higher.
- Privacy
  - Think about what you do with any images you obtain as you may break privacy laws.
     Details are available from the Information Commissioner's Office.
- Outside the UK
  - If you are visiting us from outside the UK, please be aware that drone policies differ from country to country and we would ask that you familiarise yourself with the drone policy for the UK before submitting this form to us.
- Please complete the form overleaf and return to Lydden Hill in advance of the event for approval to fly a drone over our premises.
